Search Criteria:

For an adult we have searched for VICT aged 18 and over and for Juvenile we have searched for DEFE, SUSP, RESP or PROB aged 17 and under.

The search also is for CRIME with DV offence type and DV NON Crimes.

Only DEFES (aged 10 and over) can be charged or cautioned.
