

## REQUEST

Please can I request the following information, all relating to the calendar year 2016?

**Age and gender of the youngest person arrested by your force in connection with either possession of a Class A drug with intent to supply or supplying or offering to supply a Class A drug. Please also state the type and quantity of the drug involved, all the offences for which they were arrested, the month and location (town or village) of the arrest, and what action was taken with regard to the young person.**

The youngest person arrested, was aged 13, for the offence of 'possession with intent to supply' the drug was Cocaine. The arrest was in August 2016 in Coventry and the log states that there were 2 large bags, the offence outcome was no further action.

**Age and gender of the youngest person arrested by your force in connection with either possession of any controlled drug with intent to supply or supplying or offering to supply any controlled drug. Please also state the type and quantity of the drug involved, all the offences for which they were arrested, the month and location (town or village) of the arrest, and what action was taken with regard to the young person.**
