

A. On how many occasions since September 2018 has Operation Close Pass been run and what format did these sessions take?

20 times. A cyclist on a police bike in police uniform cycling in a designated location. Where an offence is identified, it is recorded on the officer's body worn video. The vehicle is then stopped on a stop site and the driver is given an eyesight test and education around close pass. The vehicle is checked for any defects/offences and if all is in order, the driver is able to resume their journey.
