4. Again, If possible - for each year, please provide a breakdown of a.) gender, b.) whether adult or youth, c.) ethnicity of those for whom ASBIs were granted.
5. For each year, 2016, 2017, 2018, 2019, 2020, 2021 and 2022 (Jan to end of March), how many times did the police force apply for a committal to prison for a breach of an Antisocial Behaviour Injunction?
6. For each year, please provide a breakdown of a.) gender, b.) whether adult or youth, c.) ethnicity of those for whom a committal to court was applied for, due to breach of an ASBI.
