For the years 2017, 2018 and 2019 the team had 1 Sergeant and 6 Constables in the Black Country and 1 Sergeant and 6 Constables in Birmingham. A total of 2 Sergeants and 12 Constables.

2020 is difficult to quantify as the Black Country Mental Health Triage team was discontinued in March 2020. However, the team had 2 officers until the autumn in the Black Country and 1 Sergeant and 6 Constables in Birmingham.

In 2021 the team had 1 Sergeant and 6 Constables for most of the year.

The Mental Health Tactical Advisors Team was formed in December 2021, so for most of 2022 this team has had 1 Inspector, Sergeant and 10 Constables.
