

ASTON VILLA

<p>During the Aston Villa v Everton match the offender has stood up whilst in the [REDACTED] of Villa Park and shouted racial comments using words to the effect of [REDACTED]. These comments were directed at [REDACTED] Aston Villa fans and were witnessed by a [REDACTED] working on the stand. The offender was pointed out and arrested.</p>
<p>Whilst policing the AVFC v Everton football game, officers have been approached by a [REDACTED] who claimed that [REDACTED] was approached by a fan, who allegedly witnessed a hate crime. This fan stated that [REDACTED] saw that another unknown fan had been shouting [REDACTED] towards players from the stand during the game. The [REDACTED] could then not identify or find the witness to this incident, and it was not known if the witness could point out the suspect. The unknown witness was allegedly from [REDACTED] with the unknown suspect allegedly from [REDACTED].</p>
<p>BMT stated offender unknown whilst at the Aston Villa v Everton fixture sat in the [REDACTED] has been heard to shout [REDACTED] in relation to a [REDACTED] who was making [REDACTED] way towards [REDACTED]. The witness upon hearing this has deemed it to be racist and offensive, where [REDACTED] has reported it to the football club via the text line.</p>
<p>BMT stated offender unknown whilst at the Aston Villa v Hiberian fixture has been heard to shout numerous times [REDACTED]. This has been heard by the witness who has deemed to be religiously aggravated causing [REDACTED] H.A.D.</p>
<p>BMT at Aston Villa V Crystal Palace football fixture- offender has stated to the IP at the start of the match [REDACTED] to an [REDACTED] causing H/A/D</p>
<p>BMT stated Aston Villa FC were playing host to Brighton and Hove Albion FC, offender unknown have been heard to shout [REDACTED] and [REDACTED] towards the playing field. Witness has heard this, deemed the comments to be racist causing [REDACTED] H.A.D.</p>
<p>Suspect whilst being arrested for a [REDACTED] has called police officers [REDACTED]</p>
<p>BMT victim has been working as [REDACTED] staff at Villa Park searching [REDACTED] as they entered the turnstiles during which the suspect who was a [REDACTED] who was also carrying out the same role has said to the victim [REDACTED]. This was overheard by a [REDACTED] and was deemed to be a racial remark by both, [REDACTED] was removed from the post and told to leave prior to police attendance.</p>
<p>The offender has attended Aston Villa Football Club and whilst outside the upper [REDACTED] has made a comment towards to the P who is a member of [REDACTED] words to the effect of [REDACTED]. This has caused the IP H/A/D and believed this to be a hate crime due to [REDACTED] ethnicity.</p>
<p>Suspect was a football fan in the crowd at a football match between Burnley and Aston Villa. The witness was sat in [REDACTED] of the suspect. Between times, an Aston Villa players fell over and was given a corner. The suspect shouted [REDACTED]. The witness turned to the suspect and challenged [REDACTED] saying [REDACTED]. This incident happened in the hearing of multiple members of public.</p>
<p>IP was in the [REDACTED] at Villa park [REDACTED] when offender entered the [REDACTED] and said [REDACTED]. IP perceived this to be racist and reported offence to police</p>

WOLVES

At the stated times at the football fixture of Wolves V Brighton at Molineux Stadium the IP has been watching the game in [REDACTED] with a number of [REDACTED] when the Brighton Fans in the [REDACTED] have been [REDACTED] They did this by [REDACTED] The IP was shown [REDACTED] the IP believes this was directed at [REDACTED] deems this to be racist. The suspect has been pointed out by IP as [REDACTED] and has been arrested.

[REDACTED] refers. Suspect was an away fan at a football match and whilst celebrating their team, NEWCASTLE UNITED scoring they turned round to WOLVERHAMPTON fans in a [REDACTED] towards IP several times.

[REDACTED] BMT, a Tottenham Hotspur player has fouled a Wolverhampton player approximately 2 minutes into the game. Offender has seen this foul and has been seen and heard by [REDACTED] Wolverhampton fans as having shouted, [REDACTED] Offender has been arrested by police from stadium.

BMT stated offender unknown during the Wolves v Tottenham Hotspur fixture has been heard to shout [REDACTED] towards players on the playing field. The matter was reported to a [REDACTED] who informed an unknown police officer. Witness and offender details are currently unknown.

BMT stated offender unknown during the Wolves v Tottenham fixture has been seen to make [REDACTED] Tottenham Hotspur player [REDACTED] This has been seen by witnesses who have deemed the gestures to be racist and offensive.

Offender was at a football match (Wolves vs Chelsea) when [REDACTED] has been witnessed to shout [REDACTED] at the players on the pitch
